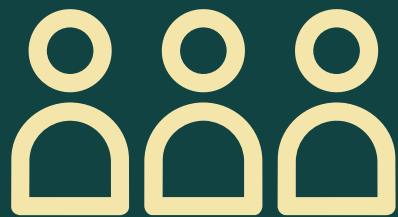
IDENTIFICATION

FEES

Payment of the applicable registration fee to the Courts.
